The ETN Board members met on 25 February in Brussels to discuss issues of strategic importance and evaluate ETN's activities since December 2014. The meeting focused on the future strategy of ETN, discussing potential new ideas and proposals. The revised proposal will be presented and discussed with ETN members at the Annual General Meeting (AGM) on 21-22 April 2015 in Dublin, Ireland. The next Board meeting will take place prior to the AGM on the morning of 21 April 2015.

# **TECHNICAL COMMITTEE AND PROJECT UPDATES**

**SOLFLEX Project:** The ETN office received the Evaluation Summary Report from the European Commission on the SOLFLEX project proposal (stage 2). Due to high competition and high evaluation criteria, the project was not selected for EU-funding. Opportunities for resubmission under future calls are being explored.

**Air Filtration Project:** The partners of the Air Filtration Project met in Brussels to define a roadmap for the cooperation with the ISO/TC 142 and to report on new project developments within the group. During the meeting, Users and OEMs also presented air filtration issues and topics of interest related to their fleets in order to identify the most important/common issues. The project group members are now working to identify topics not covered by ISO in order to define the scope of the ETN air filtration standard during the next meeting. # **EU POLICY UPDATES**

Emissions Trading System: A draft law to reform the EU Emission Trading Scheme (ETS), aimed at reducing the surplus of carbon credits available for trading in order to artificially boost the price, was backed by Environment Committee (ENVI) members in a vote on Tuesday, 24 February. The MEPs were in favor of introducing early the mechanism known as MSR (Market Stability Reserve), by the end of 2018, three years earlier than the European Commission's proposal. Members of the ENVI Committee gave the Rapporteur (MEP Belet) green light to begin trilogue negotiations with the Council, based on the amended draft report. However, the trilogue will only begin once the Council adopts its position.

**Energy Union:** On 25 February, the European Commission (EC) presented a proposal for a future Energy Union, a non-binding document outlining a wide range of initiatives to foster an EU-wide energy policy allowing for a free flow of energy throughout the EU territory. Although the idea of a common EU energy policy is not new in Brussels, it is the geopolitical situation on EU's eastern border which lifted Europe's energy security on top of EU's agenda.

The energy Union plan consists of five main close interrelated dimensions: 1) Enhancing EU security of supply; 2) Building a single energy market which is highly competitive; 3) Increasing energy efficiency; 4) Reducing energy production pollution by decarbonising our economies; 5) Boosting renewable energies by investing in R&D. As the EU treaty protects member states' power to control their own energy mixes, it is limiting the EC's power to force change. Therefore, the real impact of the energy union remains to be seen once more concrete proposals are tabled. Until then, the biggest uncertainty is whether the Member States have the political will to harmonise their national strategies.
