### **TECHNICAL COMMITTEE AND PROJECT UPDATES**

**IGTC-14:** Conference Advisory Board (CAB) meeting: The CAB met in Brussels to review the 53 abstracts received from both the industry and universities. Due to tough competition within specific sessions and the limited number of technical sessions, the CAB could only select 28 abstracts to be presented at the Conference. The ETN office will contact the authors in the beginning of February 2014.

#### **POLICY UPDATES**

**2030 Climate and Energy Package:** On 22 January, the European Commission (EC) published its plan for climate and energy policy until 2030. The EC proposed a reduction in greenhouse gas (GHG) emissions by 40% below the 1990 level, an EU-wide binding target for renewable energy of at least 27% and a reform of the EU ETS. The European Council will discuss further the framework on 20-21 March 2014. For more information, please click here.

**EU Emissions Trading System (ETS) Reform:** To achieve the overall 40% target proposed by the European Commission (EC) in the 2030 climate and energy package, the sectors covered by the EU ETS would have to reduce their emissions by 43% compared to 2005. Emissions from sectors outside the EU ETS would need to be cut by 30% below the 2005 level. This effort would be shared equitably between the Member States. To make the EU ETS more robust, the EC proposes to establish a market stability reserve at the beginning of the next ETS trading period in 2021.
