SET-Plan

As it has been regularly reported in our news summaries, ETN is actively involved in the development of the Strategic Energy Technology Plan (SET-Plan), the Research and Innovation aspect of the Energy Union. To provide input to the Action 4 "Increase the resilience, security and smartness of the energy system", the European Technology and Innovation Platform "Smart Network for Energy Transition" (ETIP-SNET) has been installed and ETN is one of its members. The ETIP has released this month its Final 10-year roadmap for the 2017-26 period. ETN has been especially committed in the Tasks T22 "Flexible thermal power generation" and D14 "Integration of the flexible decentralised thermal power generation".
