

# ETN Monthly News Summary - March 2015

## **ETN ANNUAL GENERAL MEETING AND WORKSHOP**

The ETN Annual General Meeting (AGM) will take place on 21-22 April 2015 in Dublin, Ireland and is kindly sponsored by PW Power Systems. This year's AGM will be particularly interesting to attend as the event will report on the past activities, on the current market outlook (presentation by the IEA), on ETN's future strategy, on how to maximise cooperation opportunities to face the current market environment, on the issues and requests from the user community and many more. 2015 also marks the 10<sup>th</sup> anniversary of the creation of ETN.

- 21 April 8:00 11:30: Visit of the Guinness Power Plant and Guinness Storehouse museum.
- 22 April 15:00 19:00: Visit of the Bord na Mona OCGT Peaking Plant based in Edenderry. The plant has a 125MW baseload peat moss/wood chip biomass plant and a PW Power Systems 120MW open cycle FT8 aero-derivative gas turbine plant.

### **EU POLICY UPDATES**

Conclusions of the European Council Meeting: On 19 March, Member State leaders met to discuss energy issues, including the Energy Union Strategy Framework. Their discussions focused on energy security and transparency in gas contracts and they agreed that all gas contracts must be in line with EU law, more transparent and should not negatively impact Europe's energy security. Maroš Šefčovič, Vice President of Energy Union, European Commission has stated that the objective of the European Commission is to finalise the Energy Union Strategy proposal by November 2015.
