REACHING OUT TO THE MIDDLE EAST - SERIES OF MEETINGS

In November, Christer Björkqvist, ETN's Managing Director attended the ADIPEC in Abu Dhabi, United Arab Emirates. He met with senior representatives of several companies to discuss potential cooperation opportunities in the Middle East as well as to discuss membership opportunities under the new Affiliate membership category. The feedback received so far on these meetings has been very positive and ETN will continue its efforts to increase the collaboration in this region.

Meetings took place with the following companies: Abu Dhabi National Oil Company (ADNOC), Abu Dhabi Gas Industries (GASCO), Abu Dhabi Company for Onshore Oil Operations (ADCO), Abu Dhabi Gas Liquefaction Company (ADGAS), Abu Dhabi Marine Operating Company (ADMA OPCO), Mubadala Petroleum and Dolphin Energy.

TECHNICAL COMMITTEE (TC) AND PROJECT UPDATES

Project Board and TC Chairs meeting: On 24-25 November 2014, the Project Board members and the new Technical Committees' Chairs met to align ongoing activities, discuss priority R&D topics for the future as well as to decide on how to optimise the outcome of ETN's Technical Committees.

Exhaust Systems Project: On 27-28 October, the project partners met in Florence to review the outstanding comments, in order to finalise the ETN standard. The group will continue the final review process and follow the steps which have to be taken for the standard to be submitted to ISO by March 2015.

Gas winter supply deal between Ukraine and Russia: Former EU Energy Commissioner Günther Oettinger negotiated a deal on winter gas supplies from Russia at the end of October, just before changing jobs to become the EU's new Digital Society Commissioner. A 4.6 billion dollar winter package, agreed by Russia and Ukraine, secures gas for Ukraine, and ultimately also for Europe. For more information, please click here.



IEA's World Energy Outlook (WEO): On 12 November, the International Energy Agency published its annual World Energy Outlook. Bringing together the latest data and policy developments, the WEO-2014 presents projections of energy trends until 2040. Oil, natural gas, coal, renewables and energy efficiency are covered, along with updates on trends in energy-related CO₂ emissions, fossil-fuel and renewable energy subsidies, and universal access to modern energy services.
