7th INTERNATIONAL GAS TURBINE CONFERENCE (IGTC) – CALL FOR PAPERS
The Call for Papers for the 7th IGTC-2014 has been published! The deadline to submit abstracts is 15 November 2013.

Review Papers giving a comprehensive technology overview of the past two years or Case Study Papers describing recent experiences as well as Technical Papers describing technology advances and innovative solutions are welcome in the following technical areas:

- Flexible Operation & Fuel Flexibility
- Plant and System Integration
- **Electricity Operator Priorities**
- Oil & Gas Operator Priorities
- Materials
- Turbomachinery
- Manufacturing and Repair
- Combustion

The IGTC is organised biennially and aims to raise the awareness of gas turbine (GT) technology development needs - from both oil & gas and power generation operators' perspectives - and to provide the opportunity to meet and exchange ideas with policy makers and GT experts from the whole value chain attending from Europe, North America, Middle East, and Asia. INDUSTRIAL EMISSIONS DIRECTIVE: REVIEW OF THE BREF DOCUMENT

The ETN IED Committee has spent considerable time reviewing the **Best Available Technique Reference document (BREF)** under the Industrial Emissions Directive (IED) for the Large Combustion Plant. ETN published in September a cover letter in the BATIS (Best Available Techniques Information System), stating that ETN welcomes the efforts of the European Integrated Pollution Prevention and Control Bureau in compiling a document covering the wide range of technologies. However, the ETN IED Committee's review has highlighted a number of very important concerns that must be addressed during the consultation process. The details of these concerns have been uploaded into the BATIS in September.

TECHNICAL COMMITTEE AND PROJECT UPDATES

In September, the partners of the various projects met to discuss the progress made since the last meeting as well as to decide on the next steps.

Advanced Sensors Teleconference: On 18 September, the partners of the Advanced Sensors project group had a teleconference to discuss the next steps of the project, in preparation for the ETN Workshop. Ansaldo Energia agreed to write a project proposal for each sensor project they would like to start, and present this at the ETN Workshop.

Hot Borescoping Teleconference: On 19 September, the project partners of the Hot Borescoping project had a teleconference to discuss the next steps of the project, in preparation for the ETN Workshop. Alstom agreed to make a project plan which will be discussed internally at Vattenfall and EDF as well as during a separate meeting at the ETN Workshop. The project plan should also be presented at the ETN Workshop to find additional project partners.

Exhaust Systems Teleconference: On 24 September, K. Geris had a teleconference with all Exhaust Systems project partners to discuss the next steps in the review of the common ETN exhaust systems



standard. Each partner agreed to review the current version of the standard before it will be reviewed in its entirety early in 2014.
