1. Introduction by Chair/ETN Officer

A. Pesquet opened the meeting and welcomed the sub-project group members.

2. Short report on the status of the revised standard

U. Simeoni reported the status of the revised standard and went through the actions agreed during the last meeting in London. All the actions were cleared.

3. Review of comments on the WHRES Standard

During the meeting, the present sub-PG members reviewed the comments in the draft standard, item by item. The following actions need to be reviewed for the final release.

- 1) Use *louvres* in the whole document.
- 2) Each new section of the document should start on a new page.
- 3) In some sections the word *Vendor or Manufacturer* is used instead of *Supplier* with a capital S. Check the document and replace the word where needed.
- 4) The word *Purchaser* should be always in with a capital P. Check the document and correct where needed.
- 5) Check the correct use of proposal and bid into the text.
- 6) Detail ETN in the abbreviation.
- 7) Remove the word *ref.* in the document.
- 8) Replace would and should by will and shall.
- 9) Crosscheck the *Appendix C Information provided by Purchaser* with the bullet points in the document.
- 10) Replace the words *Tube Coil* or *Heat Exchangers* with *Tube bundle*.
- 11) Change gas to process and remove offshore or onshore from the document.
- 12) Replace the word WHRU with Exhaust System if the field of application is not limited to the WHRU.

- 13) The normative reference to ISO standards in the document should be in the format ISO XXX / EN YYY or ISO XXX / API YYY.
- 14) Split the chapter 7 in two, one general for *Exhaust System engineering & system design* and one specific for the *WHRU engineering & system design*.
- 15) Paragraphs 7.4.2 remove the word *tubes and pipes* and leave *tubes*.
- 16) Validate that the use of the term *dry run* is coherent throughout the document.
- 17) Where referred to noise, replace the word *limitations* with *emissions*.
- 18) Replace higher dynamic head loss by pressure loss.
- 19) Check the meaning of the abbreviations *PQR* and *WPS*.
- 20) Paragraph 7.4.4 comments U13, U14. Reword and put in the Appendix A.
- 21) Paragraph 7.5 (e) Check the meaning of FIV assessment and the link with LCF and HCF.
- 22) Paragraph 7.4.6 (h) It is not clear whether it exist a normative on the *Fintube* or not and what type of normative reference this is.

The sub-PG agreed to schedule the next meeting on the 27-28 April in Brussels.
