Dear ETN Member,

As the President of ETN, along with our Managing Director, we wish to provide you with a brief summary of this year's accomplishments and an outline of our plans for the upcoming year.

Thanks to the focused approach and active engagement of our members, 2023 has been a highly successful year for ETN, marked by a record-breaking number of activities, projects, meetings, and webinars. Notably, we established a new Working Group on Life-Time Assessment and secured three new EC-funded projects.

With our network continually expanding on a global scale and attracting more gas turbine users, it is satisfying to see the diverse range of expertise and perspectives joining our community. This year, we achieved a significant milestone by welcoming the first insurance company to our membership marking an important achievement given their pivotal role in early-phase involvement in innovation projects.

In 2023 we have also introduced a new name of ETN Global, which now stands for Energy & Turbomachinery Network, symbolising our wider integrated international focus.

Another significant development is the Project Board's newly produced R&D Recommendation Report (the 2023 edition) and a comprehensive Roadmap, based on inputs from the user community, which provides essential guidance to our members and to policy makers.

We are now prepared and eager to follow up on these pathways through our Working Groups and collaborative projects, which are the most cost-efficient way to accelerate the transition of our technology. From a policy perspective, we continue to advocate for the establishment of a suitable market mechanism for capacity back-up power.

In 2024, we anticipate further global expansion through strategic collaborations in key markets such as the US, Canada, and Asia, enhancing our outreach and reinforcing ETN's presence to the benefit of all stakeholders. We also look forward to a successful continuation of ongoing projects and the initiation of new projects in key areas. We will also do our best in a cooperative fashion to change the perception of our technology by disseminating our significant achievements in the technology transition toward fully net-zero solutions, aligning with the technology development pathways documented in our new R&D Recommendation Report and our pursuit to become a global project dissemination platform.

Figure 1: ETN's Roadmap 2023/2024





Figure 1: ETN Key Topics, Working Groups and Projects
